TERMS AND CONDITIONS FOR THE SPONSORED LISTINGS SERVICE

By participating in the Travelscape, LLC d/b/a Expedia Group Advertising (“Expedia”) TravelAds Sponsored Listings service and/or the Vrbo Sponsored Listings service (the “Service”), you fully and unconditionally agree to these Terms and Conditions. Expedia may modify these Terms and Conditions at any time, and your future use of the Service after the effective date of any such modification is subject to you accepting those updated Terms.

YOUR AUTHORITY TO USE THE SERVICE: You represent and warrant to Expedia that: (1) all information in your registration is complete and accurate; and (2) you have full power and authority to use the Service on behalf of each property identified in your registration.

YOU ARE RESPONSIBLE FOR YOUR ADVERTISEMENTS:

You agree that you are solely responsible for any advertisement that you submit to the Service. You represent and warrant to Expedia that: (1) each advertisement that you submit complies with all applicable laws, rules and regulations and does not violate the rights (including, but not limited to, intellectual property, privacy and publicity rights) of any third party; (2) you are fully authorized to have published any advertisement that you submit; (3) any offer promoted in a submitted advertisement is valid and redeemable on the site(s) for which it is submitted, as well as through any Expedia, Inc. website (including, in all cases, Expedia.com, Hotels.com and Vrbo.com); and (4) you have adequate inventory to support any offer promoted in a submitted advertisement. Without limiting the generality of the foregoing requirements, you understand and agree that each advertisement you submit must be specific to the designated point(s) of sale and fully comply with the then-current copy guidelines, which are available at https://travelads.expedia.com/TA_Copy_Guidelines.pdf (“Copy Guidelines”), and which Expedia may revise from time to time.

All advertisements are subject to review by Expedia, and Expedia reserves the right to decline to publish, delay the publication of, or remove any advertisement, in its sole discretion, for any or no reason, and without liability to you or any other person. You agree that Expedia’s review of any advertisement shall not relieve you of your responsibility to ensure compliance with all applicable laws, rules and regulations.

If you submit an advertisement that fails the Expedia review process, you will receive a warning which provides reasons for the failure. You will then have a reasonable opportunity to revise the advertisement. If, after a warning, you do not revise the advertisement to Expedia’s reasonable satisfaction, Expedia will remove the advertisement and your listing will continue to show without an advertisement. Expedia reserves the right, in its sole discretion, to make non- substantive edits to any ad, in order to correct misspellings, capitalization errors or minor Copy Guideline infringements.

Depending on your campaign settings, images chosen beside your advertisement may be dynamically chosen from the images you provide to Expedia for your listing using an algorithm designed to choose the most impactful image for your advertisement at the time and by continuing to use the Service, you agree that the images for your advertisements will be chosen dynamically in this way. Expedia makes no representations or guarantees that dynamically chosen images will improve the performance of an advertisement or campaign. You may opt out of your advertisement images being chosen dynamically in this way at any time.

You agree to indemnify and hold harmless Expedia, its related companies, and each such company’s respective officers, directors, agents and employees, from and against any and all loss, liability and expense (including reasonable attorneys’ fees and costs) suffered or incurred by reason of any claims, proceedings or suits based on or arising out of any advertisement submitted by you, including, without limitation, claims for deceptive advertising, defamation, violation of rights of publicity and/or privacy, or copyright or trademark infringement, save to the extent that any such loss, liability or expense arises from the wilful misconduct of Expedia, or any of its related companies, officers, directors, agents or employees.

PAYMENT:

Payments and bids may be made in the currency selected when the account is created. If you fail to pay any amount that you owe for the Service, Expedia reserves the right to set off any such amount against any amounts owed to you under any other agreements you have with Expedia, however we will provide you with notice before doing so. Payments shall be paid to Expedia in cleared funds, without any deduction, and exclusive of and without any deduction for, or on account of, any taxes, imports, duties, charges, fees, levy or withholdings of any kind required by applicable law. In the event the you are required to make such a deduction or withholding, in no event shall the amount paid to Expedia in connection with this Agreement be less than the amounts that Expedia would have received absent such deduction or withholding. All amounts payable or deemed to be payable by You to Expedia shall be exclusive of any Transaction Taxes. "Transaction Taxes" means any sales, use, excise, value added, goods and services, consumption, or any similar Tax, charge, fee, duty, assessment or levy of any kind imposed by any Governmental Authority, including gross receipts Taxes that can be passed through to the consumer under applicable law and that are invoiced by Expedia to you; provided, however, Transaction Taxes excludes gross receipts Taxes that cannot be passed through to the consumer under applicable law (including, but not limited to, the business and occupation Taxes imposed by the State of Washington or any locality thereof. Any and all applicable Transaction Taxes imposed on the services or otherwise arising from the transactions of the parties under this Agreement shall in each case be paid by You to Expedia or to the Governmental Authorities as required by applicable law, unless You provide Expedia any and all documents required by applicable law to qualify for an exception or exemption from the imposition of Transaction Taxes (e.g., exemption certificates). Where permitted by law, Expedia, in its sole discretion, shall invoice You for any Transaction Taxes payable to Expedia and may elect to invoice You for such Transaction Taxes subsequent to the performance of services.

You will either pay on a cost per click (CPC) or cost per acquisition (CPA) basis, as per your campaign settings. The amount you pay for an advertisement will be determined by an auction model whereby you bid against other advertisers in the property's geographic region. The winning bid is determined at the time the advertisement is served, and the CPC or CPA (as relevant) is based on competitiveness of your bid, ad relevance, and auction dynamics. You will never pay more than the maximum price you have set.

If you are paying on a CPC basis and a user clicks on your served advertisement, you will pay the price of your winning CPC bid for that advertisement, whether or not a user makes a booking of the advertised property.

If you are paying on a CPA basis and a user clicks on your served advertisement and later books the advertised property, you will pay the price of your winning CPA bid for that advertisement.

We will automatically issue an invoice each month for any CPC or CPA amounts incurred in the prior month for each campaign under your specified billing account. Each invoice will have instructions on how to remit payment.

If you fail to pay any invoice by the due date set out in that invoice, Expedia reserves the right to put a hold on your account and remove currently running advertisements and/or decline to accept new advertisements until you have paid in full. All unpaid fees shall accrue interest until paid at the rate of the lower of 1.5% per month or the legal maximum.

CAMPAIGN MANAGEMENT:

Where available for your campaign, automated bidding is a feature provided by the Service that will automatically set bids based on a selected campaign goal or objective such as targeting return on ad spend or maximising clicks.

The Service will automatically set bids based on historical data such as historical return on ad spend or cost per click data and is subject to change.

You agree that you will make only good faith use of the Service. You also agree that you will not interfere with any other property's use of the Service. We monitor and investigate all suspicious Service activity.

Automated bidding does not guarantee campaign performance in any way. Automated bids will be adjusted dynamically throughout the day without notice.

Expedia reserves the right in its sole discretion to suspend, terminate, modify or restrict the Service, without notice, for any or no reason, and without liability to you or any third party.

REPORTING:

Expedia will make reports available through the Service, which, for each account, will detail as relevant: clicks, CPC, CPA, click-through rate, total spend and transactional data for the relevant time period. All properties in a competitive geographic region will be eligible for competitive insights reporting to the extent available. Expedia does not support third-party tracking for the Service.

YOUR CONDUCT:

You agree that you will make only good faith use of the Service. You also agree that you will not interfere with any other property's use of the Service, such as by repeatedly clicking on its ad(s). We consider this type of behaviour to be misconduct, or 'click fraud'. We monitor and investigate all suspicious Service activity.

TERMINATION OF YOUR USE OF THE SERVICE:

Expedia does not guarantee the continuing availability of the Service and we may discontinue the Service at any time. Expedia reserves the right to immediately suspend, terminate or restrict your use of the Service, without notice, if we reasonably consider that you have breached these Terms and Conditions and an immediate suspension is necessary, including non-payment of invoices as above. If we do this, Expedia will notify you, providing reasons for the suspension. You will then have 7 days to respond and remedy the breach, if possible.

In all other cases, you or Expedia may terminate your use of the Service for any reason on 15 days' notice to the other party without liability to the other party, notwithstanding the above, this does not relieve the parties from any financial obligation to pay for services up to the date of termination.

Nothing in these Terms and Conditions limits, excludes or modifies any rights you have under local laws that cannot lawfully be limited, excluded or modified.

NO REPRESENTATIONS OR WARRANTIES; LIMITATION OF DAMAGES:

To the fullest extent permitted by law, the Service is provided "as is", without warranties of any nature, and Expedia and its related companies disclaim all warranties, express or implied, in connection with the Service. In no event shall Expedia or its related companies be liable for any loss or claim (including consequential, indirect, incidental, or special damages) whatsoever, including without limitation, damages for loss of profits, business interruption, loss of or unauthorized access to information, and the like, even if Expedia or its related companies have been advised of the possibility of such damages, save to the extent that such loss or claim is caused by the willful misconduct of Expedia or its related companies.

USE OF INFORMATION SUBMITTED:

You agree that we are free to use any comments, information or ideas that you submit to us, without notice, compensation or acknowledgement to you, for any purpose whatsoever, including but not limited to modifying the Service and developing and marketing products and services.

ELECTRONIC NOTICES:

By using the Service, you agree to receive electronic communications from us. You agree that any notice or other communication sent electronically to your identified recipient will satisfy any legal communication requirements, including that such communications be in writing.

GENERAL PROVISIONS:

These Terms and Conditions set forth the entire understanding and agreement between you and us regarding the Service. Other representations we make to you are not part of these Terms and Conditions, however you may have other legal rights in relation to those representations.

Travelscape, LLC is the provider of the Service.

If this contract is formed in Australia and it is a consumer contract or a small business contract under the Australian Consumer Law, then these Terms and Conditions are governed by the laws of the State of New South Wales, Australia, and you consent to the exclusive jurisdiction of the courts of New South Wales, Australia.

Otherwise, these Terms and Conditions are governed by the laws of the State of Washington, USA. You consent to the exclusive jurisdiction and venue of courts in King County, Washington for all disputes arising out of or relating to the Service and these Terms and Conditions. The prevailing party in any dispute concerning the Service of these Terms and Conditions will be entitled to recover its reasonable attorneys' fees and costs.

No joint venture, partnership, employment, or agency relationship exists between you and Expedia. Expedia will not be deemed to have waived or modified any provision of these Terms and Conditions except by a writing signed by its duly authorized representative. You may not assign your rights hereunder to any third party unless Expedia expressly consents to such assignment in writing. If any provision of these Terms and Conditions is found invalid or unenforceable pursuant to judicial decree or decision, the remaining provisions will remain valid and enforceable, and the unenforceable provisions will be deemed modified to the extent necessary to make them enforceable.
